SCORING: NHSAA folkstyle rules with three one minute periods, with all periods starting neutral. 7th and 8th grade will wrestle three 90 second periods, with choice in second and third period. Huskerland modified rules. Double elimination for 3rd thru 8th grade. No challenge for second.

AWARDS: 3-D Arrowhead medals will be given to the top four places in each class.

ENTRY FEE: \$13.00. Late entries and call in's will be \$15.00 at the door. **Entries limited to 500 wrestlers!**

OFFICIALS: There will be five registered officials at this tournament with 2 young officials.

CONCESSIONS: Breakfast and lunch will be served. **NO COOLERS IN GYM!**

MATS: There will be at least 6 mats to wrestle on.

ADMISSION: Adults: \$4.00, Students: \$2.00

TEAM TROPHIES: 1st and 2nd place team trophies will be given in 2 classes. Class A will be the top 30%, Class B the rest.
