


Step 1A: If you have a USA Wrestling account, log in under that email address and password

Step 1B: If you do not have a USA Wrestling account, use the "CREATE FREE ACCOUNT", fill out the information and then log into the USA Wrestling account.

If you used the direct registration link and have already logged into your USA Wrestling account, you can go to Step 3, otherwise, Step 2 below will get you to the event registration site.



Step 2A: Click the USAW Events drop down menu, Select "Event Registration"

Step 2B: Choose "Nebraska" in the State menu and Date of "03/02/2024"

Step 2C: Click "SEACH EVENTS"

Step 2D: Click "REGISTER" for the NEUSA District 3 tournament in O'Neill, NE

Step 3A: If you have a USA Wrestling account for your wrestler, their name should appear under the My Profiles list, if not, you can search for your wrestler using Name and State or using the USAW ID from the USAW Card provided to you from CWO.



Step 3B: If you do not see your wrestler in the My Profiles list, you can search for your wrestler using Name and State or using the USAW ID from the USAW Card provided to you from CWO.

Step 3B: Enter either Name and State –or- USAW ID ... then click "SEARCH PROFILE"

Step 4B: Once you see your wrestlers name, click "SELECT PROFILE"




Step 5A: Choose the Available Division Options ... should be your wrestler's current grade division

Step 5B: Choose the Team Options, will likely be "Columbus Wrestling Organization"

Step 5C: Choose the Weight Option you want your wrestler registered at

Step 1B: Please enter "CWO" in the last box to make sure our wrestlers are under CWO team name




Step 6A: You must check both Consent/Waiver and Refund Policy boxes to continue ...

Step 6B: You must enter Emergency Contact Info (example, John Smith, (555) 555-5555

Step 6C: You must choose Option 1 or Option 2 ... Option 3 is not applicable for youth wrestlers

Step 6D: If you have only one wrestler ... Click "SAVE & CONTINUE TO CHECKOUT" to make payment

Step 6E: If you have another wrestler to add, Click "SAVE & ADD MORE WRESTLERS"



Step 7A: Double check that Registration Entry information is correct.

Step 7B: Click "Pay by Credit Card" and follow steps to complete registration payment.
